## SEFA COUNCIL CONFERENCE CALL May 21, 2015

Tom – Campaign results - one area still out, but best estimate suggests we're just slightly under last year. (Still awaiting updated information from Delaware-Otsego.)

Statewide RFP Committee - We have begun processing of developing an RFP for the agreement with the FCCM. Current MOU with Earthshare expires the end of this year. Matt chair of this committee. Reported that they don't have a final product yet, will have something in the next day or two.

Tom - campaign planning time.

Need to get good volunteer recruitment going - loaned associates if we're using them, or approaching our local agencies so they can name coordinators for the local program.

Have not heard anything from the Governor's office.

United Way of Buffalo has sent a letter to the Lt. Governor.

Asked for ideas from the Council.

Bill Ferguson - trying to get support from our labor unions - primarily PEF and CSEA.

Matt Ecker - have we tried to follow up our letters with a phone call?

Any avenue via OGS (thru Suzanne) that might help? Suzanne said in the past they have scheduled a meeting with someone in the Governor's office. Bill offered to work to get the support of PEF, and suggested Nick can get help from Nick.
